Trainee is to be deposited in the following SCTE&VT (O) Account through Bank Draft.



of the SCTE&VT (O) on or before 21.03.2022 for reconciliation.


No admit Cards shall be generated for the non-deposit of Examination Fee in scheduled time. The admit
