

2.	Conduct of Practical and Engg Drawing Examination by Establishment for candidates whose training/contract has finished on or before 30.10.2019	To be completed before 30.11.2019
3.	Evaluation of Practical and Drawing sheet by Establishment. Uploading of Sessional, Practical and drawing marks by establishments on www.apprenticeship.gov.in portal	To be completed by 15.12.2019
4.	Online application form submission for AITT and online payment of fees by candidate/establishments	16.12.2019 to 26.12.2019
5.	Centre mapping for Computer Based Test (CBT) by CBT conducting agency	04.01.2020 to 19.01.2020
6.	Hall Ticket Generated/ Download from Apprenticeship.gov.in and Mock Test Practice Session of CBT exam on Apprenticeship.gov.in or mockserver.cbtextam.in /DGT mock	21.01.2020 to 28.01.2020
7.	Theoretical Subject (Theory, Employability Skills and W/Sh. Calculation & Science) Exam (CBT mode). Two sessions, one for Trade Theory and second for Workshop cal. and Science and ES (combined)	29.01.2020 to 31.01.2020


